The Financial Health of a Homeowners' Association
Quote~ "The financial obligations and responsibilities of everyone who purchases a
condominium become connected, and the decisions are made largely by the elected board.
Owners seldom think about the connectivity between everyone living in a homeowners"
association. The association has expenses an owner in a single-family, non-homeowners'
association residence does not, such as the cost of operations and administrative expenses
of the association, commercial liability and property insurance requirements for property of
the whole group, and often the cost of maintaining common amenities. Associations have to
pay commercial rates rather than residential rates for property coverage, so it tends to be
more expensive. There are Reserves that have to be set aside and owners in nonhomeowners' association housing tend not to save with the same diligence..."
KEY POINT: "The reality of owning in a homeowners' association is that decisions are made by
someone willing to serve on the Board. If you are not willing to serve, you do not get to make
any decisions. You will get to vote on some things, but not on all issues." ~ End Quote
